Rex Park Drainage Project Bid
Request:

- Installation of up to 2ft x 80ft x 3ft
deep drainage cavern
- Installation of up to 8ft x 20ft x 3ft
deep drainage cavern between poured
in place and basketball court
- Installation of up to 8ft x 8ft x 3ft
deep drainage cavern between poured
in place with swings and the sidewalk
- Retaining wall along fence, approxi-
mately 205 feet
- Finish landscaping

CONTRACTOR REQUIREMENTS:

- A. Prevailing wage shall be paid.
- B. Furnish Performance and Payment
Bond-Completed Contract Method
- C. Bidders MUST submit a bid on ALL
Task Items & Specifications.
- D. Bidders MUST submit bid on
Company Letterhead, Signed by
Principal and Manager.
- E. Bidders
MUST provide Proof of Insurance
Certificate of Coverage, at the time of
signed contract agreement. If any of
the coverage expires during the term
of the agreement, the bidder shall
hand deliver renewal certificates to

least ten (10) days prior to the
Certificate of Coverage expiration date.

- 1.1 Quotations must NOT be
submitted by facsimile, email or any
other electronic format.
- 1.2 Submit itemized comprehensive
Statement of Work.
- 1.3 Quotation prices shall remain in
effect for a period of ninety (90) days
from the Quotation due date.
- 1.4 All Prices submitted shall be
quoted in U.S. currency.
- 1.5 Bidders shall be prepared to meet
with city officials upon request.
- 1.6 Supplemental information and
pictures accepted, as necessary.
- 1.7 Provide references of at least
three (3) clients.
- 1.8 List sub-contractors, including
Principal Owners.
- 1.9 It is the responsibility of the
Bidder to understand all aspects of the
RFQ and to obtain clarification if neces-
sary before submitting quotation.
- 1.10 Contractor to be paid at 45 day
intervals with final payment minus
15% within 120 days of project
completion. Remaining 15% will be
paid upon inspection and approval of
100% of Task Items by the City and St.
Louis County Municipal League Grant
Commission.
